Applying directly with the Department of Home Affairs 直接向澳大利亚内政事务部申请

Depending on the visitor visa that best applies to your circumstances, you will need to either download an app or create an account through ImmiAccount (the online platform for Australian visa applications). Links are provided at the end of this document.

Important: please **do not include anyone** on your visa application. Each traveller will need to apply for their own visa.

Completing the application 填写申请表——请注意

- Respond carefully and truthfully to all questions and ensure you provide the answer that best applies to your circumstances
对所有问题都要仔细真实地回答，并确保您提供的回答最能符合您的情况
- If you are visiting Australia for business meetings, please select 'Business' under the question 'Your purpose of stay in Australia'

- Read carefully and complete the Declaration.

- Upload the documents required. Failure to do so will delay your application

Biometrics required to apply for visa? 申请签证需要生物识别吗?

VIP Guests are **not eligible for the biometrics waiver** and as a part of lodging a visa application in a country included in the biometrics program, regardless of nationality, you might need to provide your biometrics in relation to each visa application you lodge.

VIP 贵宾**没有资格享受生物识别豁免**，作为在生物识别计划所含国家提交签证申请的一部分，无论国籍如何，您可能需要在提交的每份签证申请中提供您的生物识别信息。

After you submit your visa application online, the Department of Home Affairs may request your biometrics via an automated email. You must arrange an appointment at the nearest biometric office so they can be collected.

在线提交签证申请后，内政部可能会通过自动电子邮件要求您提供生物识别信息。您必须在最近的生物识别办公室安排预约，以便领取。

The nominated biometrics collection agency will capture a facial image with a digital camera and a 10-digit fingerprint scan with a digital finger scanner. To check, [click here](#).

Documents required to apply for visa 申请签证所需的文件

- **Passport:** clear colour copy of the photo page of your passport. If your current passport is close to expiry, you can still use it however you must upload your new one later through your ImmiAccount or you may be refused boarding an aircraft.

护照：护照照片页的彩色清晰复印件。如果您目前的护照即将过期，您仍然可以使用，但必须随后通过您的移民账户上传新护照，否则您可能会被拒绝登机。

If the visa applicant is **under 18 years of age** you must submit one of the following forms:
如果签证申请人未满 18 周岁，您必须提交以下表格之一：

- **Form 1229* (if the participant is under 18 years of age & applying for a subclass 600 visa and travelling with one parent):** this is 'consent to grant a visa to a person under 18 years of age'.

表格 1229* (如果参与者未满 18 周岁，且申请 600 子类别签证并与父母一方同行)：这是 " 向未满 18 周岁者签发签证的同意书 "。

- **Passport of the other parent** if the player is travelling with one of the parents.
如果球员与父母一方同行，**另一方父母的护照**。

- **Form 1257* (if the visa applicant is applying for a subclass 600 visa and travelling without any parent)**

- **Passport of both parents** if the player is not travelling with any parent.
如果球员未与父母任何一方同行，则需提供**父母双方的护照**。

* **Note:** If children are eligible for an ETA (601) the above forms will not be a requirement. If they are eligible for an eVisitor 651, then this may be a requirement (as this application may be manually processed as opposed to automatically processed)

Information required to apply for visa 申请签证所需的信息

- **Travel dates:** provide your travel dates to and from Australia. You cannot enter Australia after your indicated departure date: *e.g. if you apply to enter on 1 December 2024 and depart on 30 December 2024, you will not be allowed to enter Australia after 30 December.*

旅行日期: 提供往返澳大利亚的旅行日期。您不能在指定的离境日期之后进入澳大利亚: 例如, 如果您申请于 2023 年 12 月 1 日入境, 并于 2023 年 12 月 30 日离境, 那么您将不能在 12 月 30 日之后进入澳大利亚。

- **Application location:** apply for your visa OUTSIDE of Australia (applying within Australia requires further documentation and creates delays).

申请地: 请在澳大利亚境外申请您的签证 (在澳大利亚境内申请则需要提供更多文件资料, 会造成延误)。

- **Eligibility requirements:** your visa application may request you to provide further information to ensure you meet their health, character or health insurance requirements. For full details of the eligibility requirements scroll down.

If you currently hold a visa to enter Australia, you may check with your Australian Embassy or the Visa Entitlement Verification Online (VEVO) to check your visa validity details and visa conditions. New Zealand passport holders 新西兰护照持有者

New Zealand passport holders are generally eligible for a Special Category visa (subclass 444). More information about this visa can be found [here](#). We recommend that you check the requirements for a visa Subclass 444 in advance and before you travel. No letter of invitation from Tennis Australia is required to obtain this visa.
