# Applying directly with the Department of Home Affairs 直接向澳大利亚内政事务部申请

To apply directly with Australia's Department of Home Affairs (DHA), you will need to: 要直接向澳大利亚内政部(DHA)提出申请,您需要:

- Create an account through ImmiAccount (the online platform for Australian visa applications) 通过 ImmiAccount (澳大利亚签证申请在线平台) 创建账户
- 2. Select the visa type 选择签证类型
- 3. Complete the visa application form 填写签证申请表
- 4. Attach the required documents 附上所需文件
